

Canadian Multiculturalism Day Celebration: Terms & Conditions - Please read carefully:

- One of the main conditions to be a vendor of this event is to present culturally diverse products or services.
- Please note that this event is being held from 10:00am to 2:00pm! Make sure to be able to stay throughout the whole event as it will be very hard to wrap up while there are still people visiting the event.
- A tent, chairs or any other type of accommodation will not be provided. The sports are limited so the registrations are approved and confirmed on first come first serve basis.
- CANCELLATION OF YOUR SPOT Please, if you need to cancel your table, give us <u>at least 2 weeks' notice</u> in order to be able to fill the spot. Even if you are not certain, let us know so we can arrange a backup participant. Remember the event is happening rain or shine.
- You are required to check in with the Event Coordinator at the spot **prior** to unloading to your location. No changes to the site plan will be considered on the day of the market.
- Set up time & map will be sent to you 1 week prior to the market date. Please consider making arrangements with transportation, as parking will be limited.
- You will be allotted a 10'x10' area. Vendor is responsible for giving the Family Education and Support Centre ample notice to re-allocate the location.
- Vendors are required to supply their own tables, chairs, tent, & business signage. Unfortunately, we are not able to supply table or tent
 rentals to Vendors. If utilizing a tent, tent weights of 20lbs or more PER LEG will be required. This is MANDATORY by the City of Maple
 Ridge and will strictly be enforced. Please visit the City of Maple Ridge website and review the details on appropriate &

- The Multiculturalism Day market will coincide with the Fraser North Farmers Market (Haney Farmers Market) which is in Memorial Peace Park. - The vendor will sell only items listed on the application form, to avoid duplication. If you are selling anything other than what you have declared on this
 registration without prior written consent from The Family Education and Support Centre, you will be asked to remove said items from your location, failure to
 do so will result in being removed from the market.
- Your location will not have access to power for any reason, or water. There will be bathroom facilities located around the festival, The Family Education and Support Centre will not be responsible to cover your booth.
